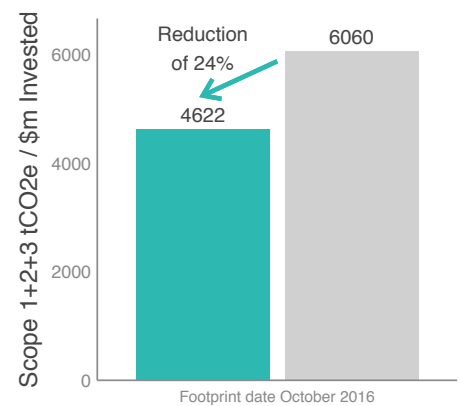

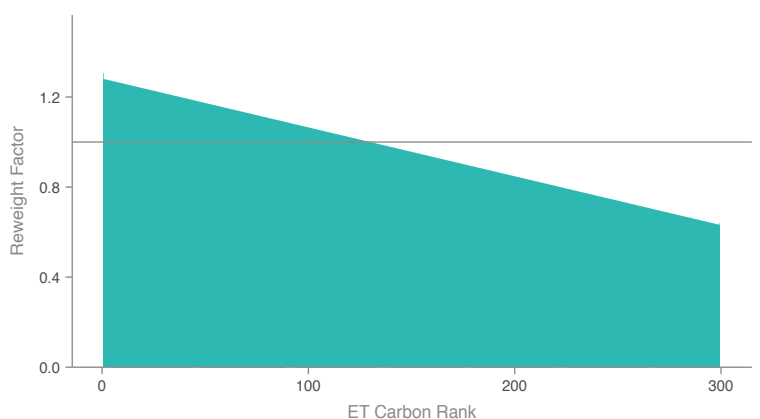

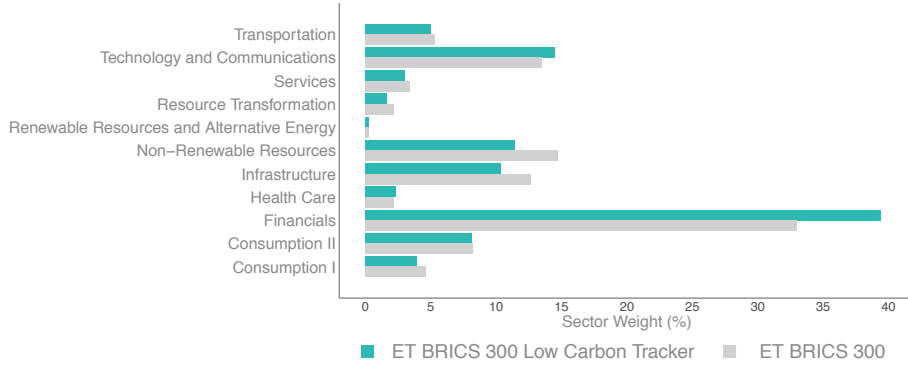
Constituent Reweights by ET Carbon Rank

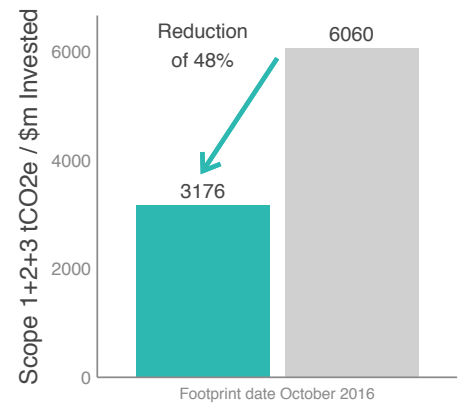

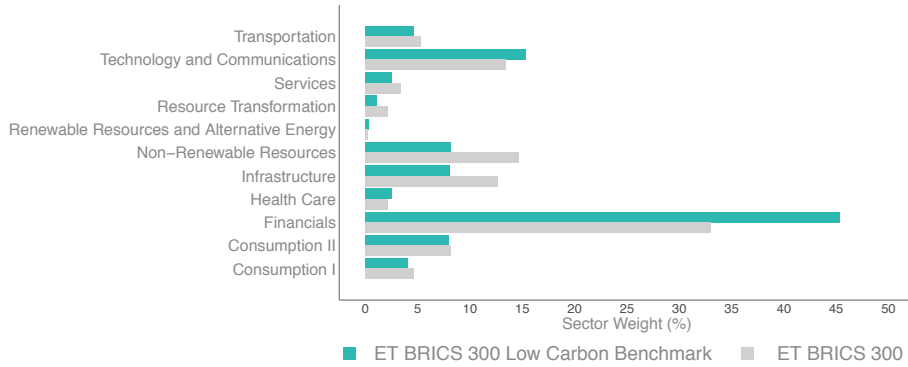
Constituent Reweights by ET Carbon Rank

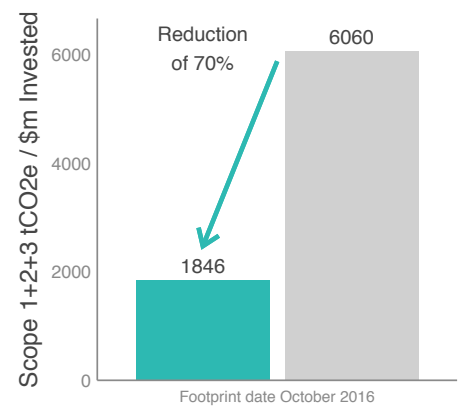

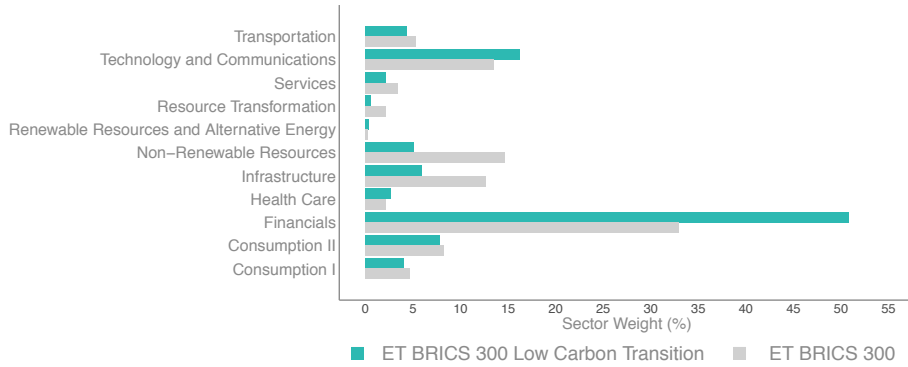
Constituent Reweights by ET Carbon Rank

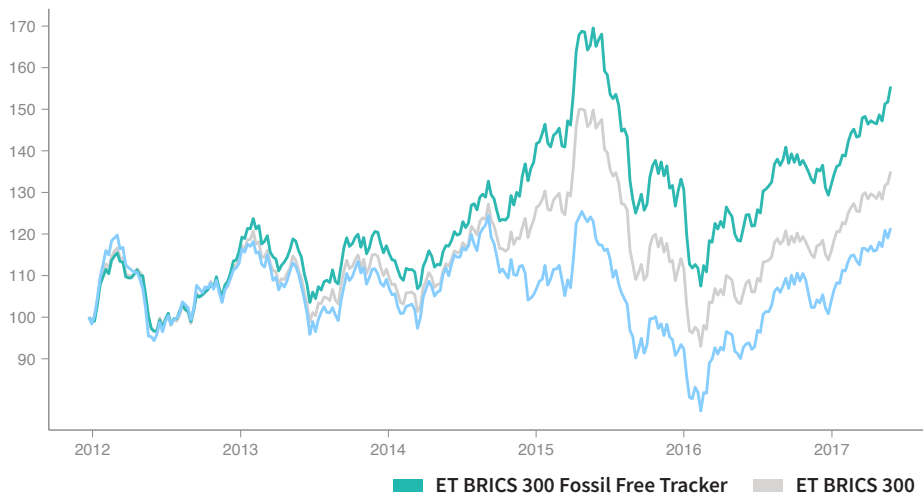

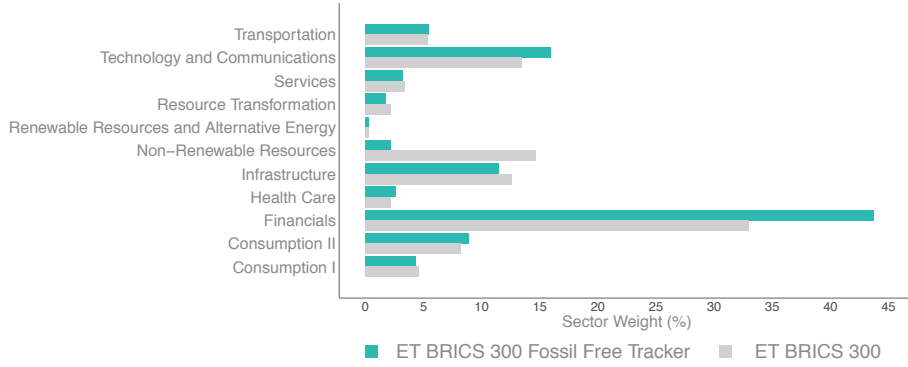
Constituent Reweights by ET Carbon Rank

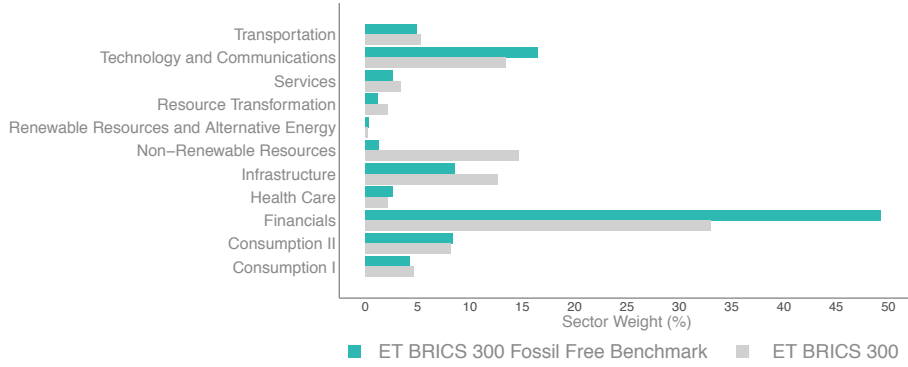
Constituent Reweights by ET Carbon Rank

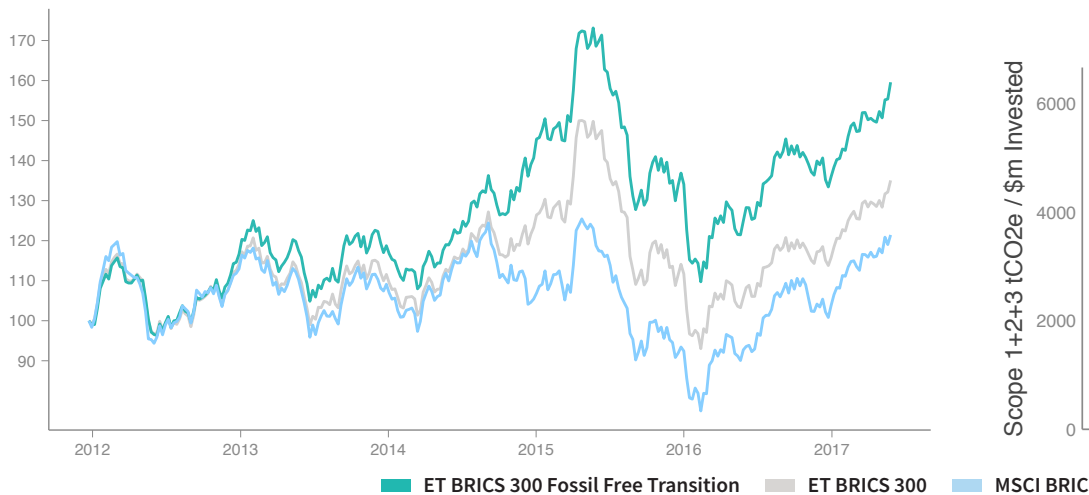

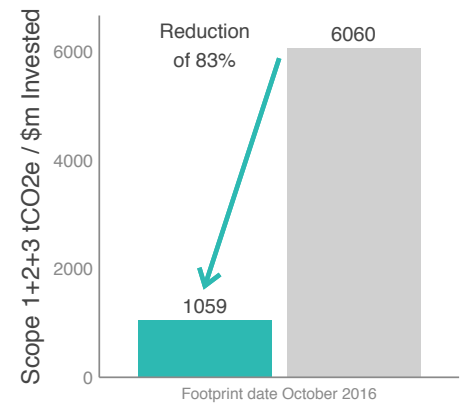

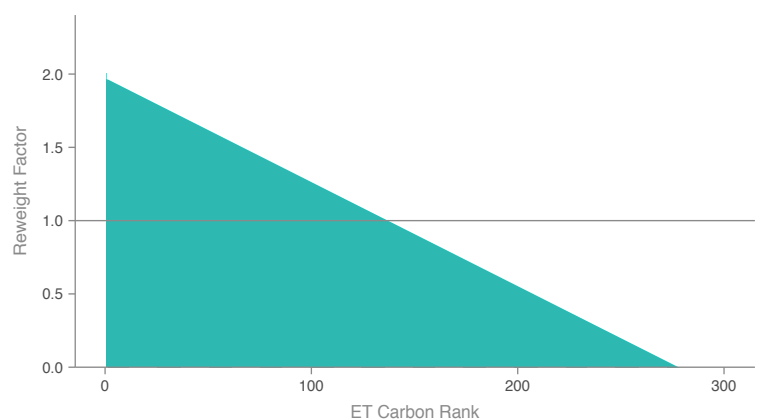

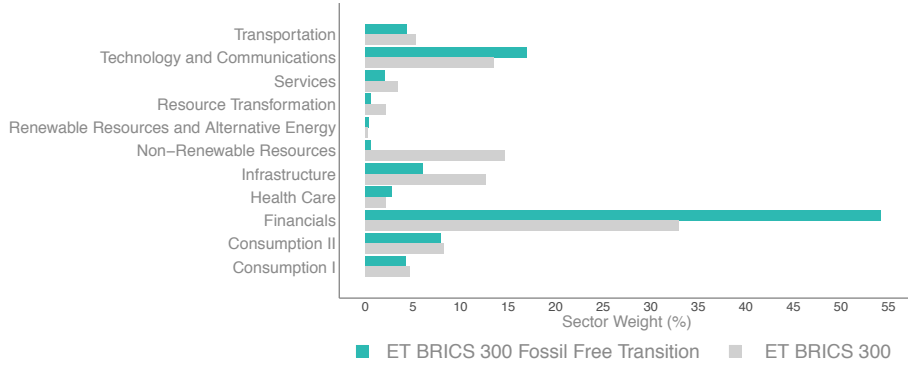
Constituent Reweights by ET Carbon Rank
